Project Description:

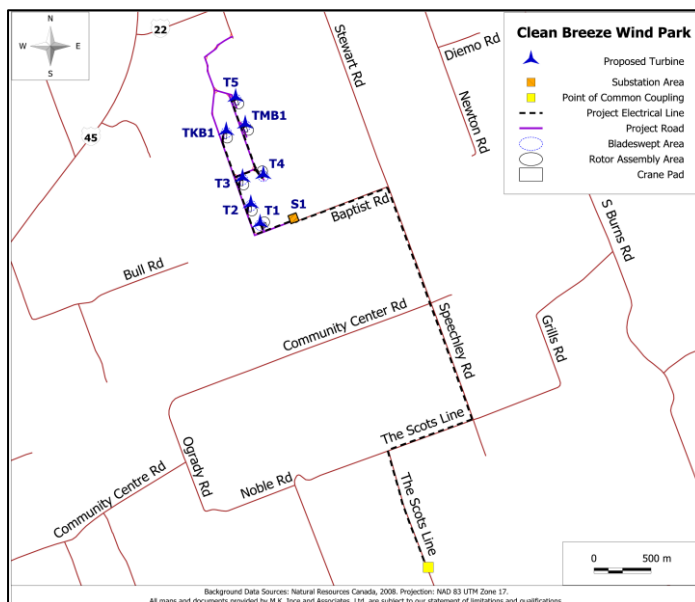
Pursuant to the *Act* and Regulation, the facility, in respect of which this project is to be engaged in, is considered to be a Class 4 Wind Energy Generation Facility. If approved, this facility would have a total name plate capacity of 10.0 MW. The project location is described in the map below.

The Draft Project Description Report entitled *Clean Breeze Wind Park Project Description Report (Draft)* describes the project as consisting of five (5) 2 MW wind turbine generators (to be constructed at five of the seven sites), wind turbine foundations, transformers, gravel access roads, underground electrical cabling, and other ancillary works.
